- Follow all FAA and Florida State Statutes guidelines (including Statute 934.50)

### **IMPORTANT! IF YOUR PRODUCTION IS GOING TO USE A UAS/DRONE**

- Drones are prohibited within 500 feet of any government or municipal buildings
- There is **NO DRONE PHOTOGRAPHY ALLOWED** in any National, State, County or City Park/Beach
- You must obtain a permit when launching from *any* public property
- Respect privacy

Approval of this permit does not exempt the APPLICANT from obtaining applicable permits from Federal, State, Regional and/or local agencies.
